UC Davis Tech Trek Camp 2017. School closures due to snow have pushed back the nomination process from our 7th grade teachers at North Tahoe School. These teachers are the start, and backbone, of our Tech Trek program. Tech Trek Chair Meri McEneny hopes to meet with the teachers the week of January 17-20, weather permitting, to help with forms or answer questions. NT AAUW once again will send 6 girls to TT. This year's camp is July 23-29, 2017.

The UC Davis camp branch coordinators met in Roseville on January 7th to discuss the schedule, fees, and any changes to the UCD camp where our NTS girls attend. Meri and a few others attended via phone conference. The UC Davis camp serves girls from Siskiyou County to Marysville to Truckee and Tahoe.

Martha Rees and Susan Wheeler are camp coordinators again this year. Yeah! Martha and Susan are prepared, flexible, fun and responsive to the branches, girls and parents. They are committed to keep the camp fees at \$900 per girl. They achieve this by (1) eliminating vehicle field trips (all excursions are within walking

distance on the UCD campus), (2) keeping the same dorm (Thompson Hall) which has sufficient meeting space on-site and no other rooms need be rented, and (3) by keeping the core classes consistent, but updated, so materials can be reused. Staying with Thompson Hall keeps the camp size to 94 girls.

Local Tech Trek Event. Christine Marsh-Madden and Meri McEneny met recently to brainstorm ideas for a proposed 1-day Tahoe Tech Trek event this Summer for up to 50 former NT AAUW Tech Trekkers still in our school system. Two rooms at the TCPUD Fairway Community Center have been reserved for Saturday, June 10, 2017. Christine and Meri have committed \$1,000 to the event.

Two professional women scientists have agreed to lead a class that day and several more have been contacted. We also hope to enlist women from the local Sierra Watershed Education Partnership (SWEP) and Tahoe Environmental Research Center (TERC).

We hope our NT AAUW members will join us on June 10, 8am-3:30pm, to help with registration, snacks, and working with the girls and the presenters. More details on costs to follow once the classes and teachers are confirmed. Costs to date are \$343 for room rental (includes a \$100 refundable deposit). We are excited!



The weather threw a monkey wrench into lots of planned events, not the least of which were the interviews needed for Girls State. NTHS was out for the entire week plus Martin Luther King, Jr. Day. Of course, the Interviews will be rescheduled as soon as possible. Perhaps a nonsnow day will be picked this time around.
