Transactions (Revenues/Expenditures) highlights through Dec 31, 2019:

- 1. Operating Funds
 - a. Membership. Revenue/Expenditure mismatch since some dues were collected before the FY began in July but all pass-throughs to National and CA were paid since July.
 - b. Social Events.
 - i. Petra paid in November with a new check to replace the lost check. Net proceeds \$522.50.
 - ii. December Holiday Party proceeds will be \$0 after one refund check is cashed.

2. Program Funds

- a. Tech Trek. Allen Foundation contribution of \$1,000 brings branch funding to \$7,771. Sufficient to pay \$4,500 fees for 5 campers.
- Scholarships. \$7,970 funding is sufficient to fund \$4,000 scholarships (\$2k+\$1k+\$1k) at end of FY. TTCSC will transfer \$1,690 balance held for AAUW NT to TTCF Donor Advised Fund.
- c. Girls State. \$580 funding sufficient for \$450 travel stipend. (ALA carryover covers fees)
- d. AAUW Fund. CY contributions of \$1,531.50 sufficient for 2 named gift awards.

I wanted to make sure that Chad didn't think his new teachers would be overloaded in their first semester. They will submit their 10 nominated 7th grade girls by January 10, 2020. - Meri will meet the nominated girls at NTS the week of Jan 13-17, 2020. The girls will receive an overview of camp, their application, instructions and deadlines.

STEM Trek day:
