What a strange year it's been, interrupted by an unseeable force of nature that has altered the way we interact with one another.

Some recent **positives** for our branch:

- Our scholarship program will be supporting <u>three</u> <u>young women</u> in their college careers (our newest, as well as our two returning champions as they progress through their sophomore and junior year).
- Our finances are stable thanks to the generosity of our members and Patricia Watters' sound fiscal management.
- Our interest groups and the leadership team have continued to meet and thrive through the magic of ZOOM. We sincerely hope that you all join in our June meeting (details on next page) distance is no deterrent!

The **negatives** for our branch:

- Five wonderful girls selected for a magical week of exploring science and themselves which was canceled in the wake of the virus...
- …Another deprived of the opportunity to experience how government works (or doesn't).
- The opportunity for 30? 40? 50! girls (and let's be honest—plenty of our members as well!) for a day of hands-on learning about aviation science has been postponed indefinitely.
- Missing the socializing that occurs with each AAUW meeting, general or interest group.
- No Truckee Town parade to help us celebrate the centennial of women's suffrage.

Which brings to mind the core advocacies for AAUW in 2020 and beyond: Pay Equity - Paid Sick and Family Leave - College Affordability - Campus Sexual Harassment and Violence - Health Care Access and Reproductive Rights - and Voting Access.

In this year in particular, **voting access** is crucial. Although voting is a fundamental right, increased public health concerns this election season as well as increased voting restrictions and suppression, threaten our access to vote. While voting suppression historically came in forms ranging from literacy and citizenship tests, poll taxes, identification cards, and outright physical intimidation, today there are persistent and renewed restrictions. The 2013 U.S. Supreme Court decision in Shelby County v. Holder rescinded key protections of the Voting Rights Act. There are current threats still evolving: the gerrymandering of districts which dilute the power of neighborhoods, polling place closures in predominantly minority census tracts, registration record purges, the attack on voting by mail, and the amplification of unsubstantiated "voter fraud" charges.

Just this past week, the Republican National Committee, the California Republican Party, and the National Republican Congressional Committee have sued to stop the State of California from mailing an absentee ballot to every registered voter. So while we won't be able to remind our community of the importance of the 19th Amendment at the Truckee Town Parade, we can all VOTE and be active in our communities to ensure that every citizen votes. We sincerely hope everyone has a healthy summer...

FINANCE CORNER

Although our fiscal year (FY) is not over until the end of June, I would like to report on the financial health of our

Branch Operating and Program accounts. Because of your generous contributions, support from local organizations, and the efforts of our Leadership team, Branch Operating costs and Programs were fully funded for the 2019-20 FY.

....Then, along came COVID-19 to challenge our world. The AAUW-CA convention was cancelled.The Tech Trek, STEM Trek, and Girls State programs were suspended. Funds for these programs are held within their respective accounts, available for next year's programs. Two of our members will be honored with a \$750 gift to AAUW Fund given in each of their names this year. We will also provide \$4,000 in scholarships for local girls focusing on STEM studies.

Our greatest need, going into FY **2020-21**, will be to **build the Scholarship account** for next year's scholarships of **\$5,000** for local girls focusing on STEM studies. Please consider contributing to the "<u>Undesignated Contributions</u>" subaccount of the AAUW NT Donor Advised Fund (DAF) held at Tahoe Truckee Community Foundation (TTCF). You will be able to claim a tax deduction for the contribution in the current tax year. The Leadership Team may allocate these contributions to Branch programs, as needed.

An accounting of the Branch Assets and Net Operating Income is on page 6 (end of newsletter). Net Operating Income "appears" negative because FY Income does not include Dues collected in the prior FY. Unfortunately, I can't retrieve the June 2019 records of bank deposits for FY 2019-20 Dues because I'm staying at home in Templeton now, and the records are at my Lake Tahoe home. Our Branch dues of \$31 per member generate sufficient income to cover Branch expenses.

Tech Trek 2020

Due to the cancellation of Tech Trek camp at UC Davis this summer, we are trying to create a way to honor, educate and entertain the 5 girls selected this year. Without being able to offer our *cancelled* 2020 STEM Trek Day to these 7th graders, I offer to pursue a <u>local one-day event</u>, outside, with social distancing, not more than 10 people, to focus on **outdoor skills** such as: how to pack a backpack, Leave No Trace principles, botany and ornithology.

I watched the AAUW discussion with Dr. Sarah McAnutly regarding her program <u>Skype a Scientist</u>, which allows students, teachers, families, adult book clubs, etc., to sign up for a 30-45 minute online class with a scientist. There are currently 5,000 scientists in their database. This might fit right in with a program for our Tech Trekkers this summer. Anyone want to help? Tahoe League for Charity, a generous supporter of Tech Trek, sent us an application for their 2020 grant program, and I have applied for a grant even though our camp is cancelled.

I notified <u>Rotary Club of Tahoe City</u> that their generous 2020 grant, received early in the year, would be held for the 2021 camp.

STEM Trek Day (STD)

It's been cancelled, as you know. Regarding the invitation to engage virtually with the staff of STD invitee, Senator <u>Jacky Rosen</u> from Nevada, none of the other branches committee members were interested in following up with them, but that door seems to be open when we are interested, particularly for STD 2021.

I contacted <u>Kiwanis of North Lake Tahoe</u>, a supporter of STD, to say the event was cancelled and we would not be applying for a grant, especially since the major Kiwanis fundraiser Benefit Auction and Wine Tasting was not scheduled this year, but we hope to resume our relationship next year.

I reminded supporter <u>Tahoe Truckee Airport District</u> that we might have an opportunity to collaborate for the <u>September 26, 2020</u>, *International Girls in Aviation Day*.

We did not receive a grant for STD this year from AAUW-CA.
